## **Terms and Conditions**

General: WiWi-Online is a communication and information platform for students, graduates and teachers in the fields of economic sciences as well as for companies. The private use of WiWi-Online is free and open to everyone. Refer to our current price list for partner company terms. Registered users receive a monthly member newsletter via e-mail to the specified address. Each natural person may only register with one e-mail address at WiWi-Online. The data provided at WiWi-Online is intended only for private use. Commercial use requires the written permission of WiWi-Online. Any automated use of WiWi-Online, e.g. via offline browser, download manager, etc. is strictly prohibited. Non-compliance with these terms will be cause for criminal or civil prosecution.

Profile: WiWi-Online gives every user the option of creating a personal profile. The profiles of private individuals (student, young professional and researcher user groups) will be anonymous. Personal contact details will not be published or shared with third parties. Contact requests will be forwarded by WiWi-Online. Academics' profiles and the profiles of partner companies can be viewed by all users. Profiles of private individuals (see above) can only be viewed by our partner companies. They may make use of filters to select profiles of potential suitable employees.

Personal information: Personal contact information is stored by WiWi-Online only for the purpose of replying to contact queries. Third party access to the information we collect: WiWi-Online shares no personal data with third parties. However, WiWi-Online is authorised to make this informational available to authorised outside service providers inasmuch as this is necessary for technical administration.

Log files: For reasons of data security Internet protocol (IP) addresses are saved to log files and this information is used for anonymous statistics, recording the number of visitors to our site. User profiles are neither created, nor is this data collated with any other information.

Changing your profile information: To prevent misuse, any changes made to profiles are only published after being reviewed by WiWi-Online. Approval normally takes place on the next business day.

Data security: WiWi-Online will take the appropriate measures that are currently technically feasible to protect your information. Upon registration you will receive your password in an unencrypted e-mail. You may make use of WiWi-Online only if you consent to this manner of receiving your password. We recommend changing this password as quickly as possible.

Links: We assume no liability for the content or data protection practices of other web sites that are linked to on our web site.

Cookies: WiWi-Online uses cookies. These are deleted when you log out from your personal area or no later than 10 days afterwards.
